



## **BLADE DISASSEMBLY & ASSEMBLY:**

## Blade Disassembly




Push back the white ceramic blade with your thumb as shown in the above picture




Please catch the disassembled blade with your other hand.

#### Blade assembly



Put the blade (B) into the slot (A) of the clipper



Push down the blade until you hear a sound

Remarks: The clipper can be cleaned under the faucet.

## **WARNING:**





Don't disassemble the product by yourself.

NOTE: Product is IPX7 washable, it can be put under the faucet.





- 3. Product can be wiped or cleaned with wet cloth or neutral liquid soap.
- 4. Don't charge product in the environment above 104°F (40°C) or below 32°F(0°C)
- \*Product will be a little hot while charging, which is normal.
- \*Please remove the battery from product and put in the specified recycling place after battery life has ended.

#### **ENVIRONMENT-FRIENDLY & RECYCLE:**

Please remove the battery from product when you decide to discard the product, and put battery in specified recycling place.

- 1. Let the product work until the battery has been completely discharged.
- 2. Turn off the product before disconnecting the power, then remove battery from product.

#### **BLADE CLEANING & MAINTENANCE:**


#### Blade cleaning



1. The Blade can be disassembled for cleaning.




2. Clean blade with cleaning brush.



3. The ceramic blade can be pulled up for cleaning the hair left in betweem the moving and fixed blade.

Blade maintenance



Put little bit of lubricating oil on left, middle and right area of the moving blade, before or after using the clipper for maintenance.

#### **CHARGING METHOD:**

- 1. Plug one end of the charging cable into the charging slot and another end to the USB pin connector.
- 2. When the LED display turns on, it means the trimmer is getting charged.
- 3. When the battery power has reached 99, it means the battery has been fully charged.
- 4. Please charge for about 4-5 hours when using for the first time (To activate the rechargeable battery) .
- 5. The charging time should not exceed 10 hours.

#### **GUIDE COMB FUNCTION:**

The product comes with 6 guide combs which can meet all your different grooming requirements. The six guide combs also include the left and right combs can help you control the trimming orientation and make your look more stylish.

- 1. Determine the hair length that you want.
- 2. Select the appropriate guide comb.

#### **INSTALLING THE GUIDE COMB**



- 1. Slide the clipper up to the top of the guide comb.
- 2. Make the clipper into the slot of the guide comb.

### TAKING OFF THE GUIDE COMB



- 1. Make sure you see the back of the clipper
- 2. Then push the lower part of the guide comb up with your thumb

#### HAIRCUT:

- 1. Select the appropriate guide comb.
- 2. After installing the guide comb, switch it on and move the back of the hair clipper along the hair and trim the hair as per your length requirement.
- 3. Do not use the hair clipper in reverse to avoid over-trimming (Figure 5).
- 4. Do not keep the trimmer in one place. Keep moving slowly (Figure 6).
- 5. When there is guide comb, the length of the trimmed hair is about 1 mm. Trimming with shaving comb
- 6. Take off the guide comb and rotate the adjustment knob to make the hair cutting blade rise. Then, the hair can be thinned and trimmed.

- 7. Adjust the amount of hair while cutting to prevent excessive hair loss
- 8. Trim the hair near the forehead and make the bangs look natural (Figure 7).
- 9. Gently brush over the heavy hair part to make the overall hairstyle even and natural (Figure 8).


If the hair clipper does not start up immediately, the cause may be that the battery is overused.

Please turn off the switch and turn it on after a few minutes to use it normally.

Please Note: Overcharging of the clipper may lessen the battery life of the clipper Not using the clipper for a year or more may make the battery completely dead and might require replacement. Hence, it is advisable to use the product at least once in 4 months.

## **COMMON PROBLEM:**

Common Problem	Reason	Approach
Charging indicator does not light up	Wire contact problem	Check the charging cable connector and USB charging interface
	Display light damage	If it can be charged normally and does not affect normal work, it doesn't matter) if it needs repair please contact customer care service.
	Low Battery(not used for a long time) Charging circuit failure	Continue charging, it will become normal after about a few minutes. If it can not be used normally, please contact customer care service.
Overtime charging	Not charging with original charging cable	Use original wire for charging
	Battery life is over	Please contact customer care service
	The charging circuit is faulty and cannot be fully charged.	Please contact customer care service

Common Problem	Reason	Approach
Power on but not working	Low battery	Connect the charging cable to charge
	Switch failure	Please contact customer care service
	Circuit failure	It can not be used normally, Please contact customer care service
Clip hair	Lower power, lower cutter speed	Connect the charging cable to charge
	Inadequate lubrication of the clipper head	Lubricate the clipper head
	Motor or battery failure	Remove the shaver head, clean it and the body, then reinstall and connect the charging cable to charge for 30 minutes. If the blade cannot be gently clamped, it indicates the motor or battery malfunction, Please contact customer care service
	The shaver head is not lubricated enough.	According to the instruction manual, drip oil on the shaver head.
Loud volume	The shaver head is entangled with hair.	Clean the hair on the shaver head and body
