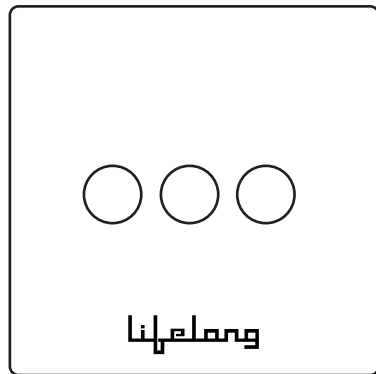

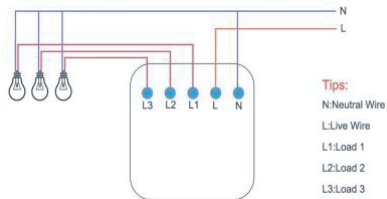

Please ask for help from a professional electrician and switch off AC mains before installing.

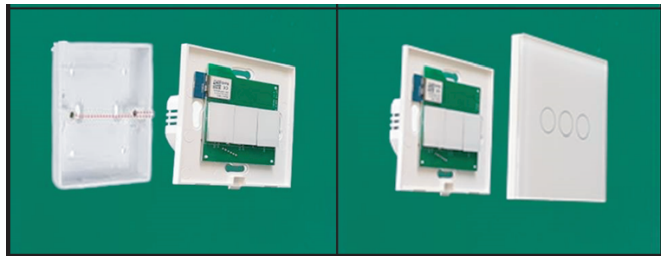
## INSTALLING THE DEVICE

Fit the back of the smart switch in 3x3 inches electrical box

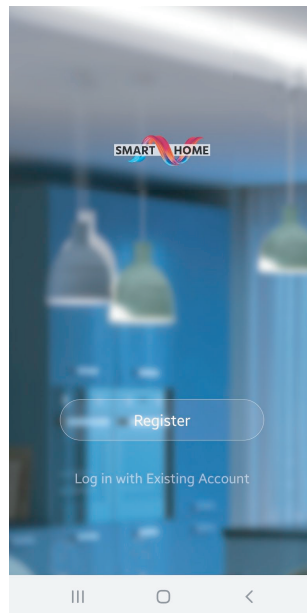
Close the back and front of the smart switch together.

## ADDING THE DEVICE

1. Make sure your mobile phone is connected to Wifi.
2. Power up the smart touch switch.
3. In the Lifelong Smart App home page, tap the icon “+” on the top right corner or click the “Add Device” button.
4. Select “Add Manually” from the top carousel.
5. Select “Touch Switch”. This will take you to the device detection page.
6. Once on the detection page, Reset the device by pressing any touch button for more than 3 seconds. An indicator should then start blinking.
7. In the App, Press the “Confirm indicator rapidly blink” button.
8. In the next screen, enter your Wifi name and password.
9. The device will get connected automatically and you will be taken to the Device screen in the App.
10. By default, the name of the device will be “Three-Gang Switch”. You can edit it to any suitable name.
11. Your device is now connected and ready to use.

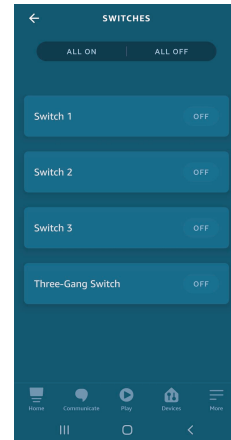
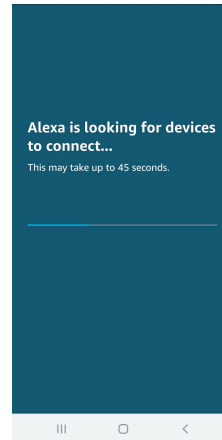
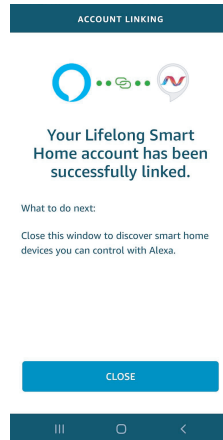
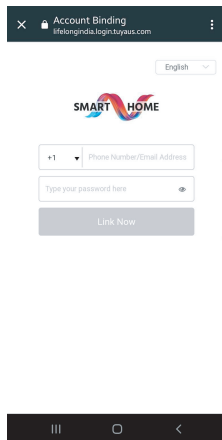
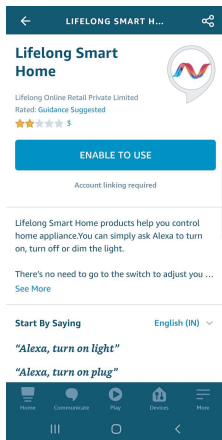
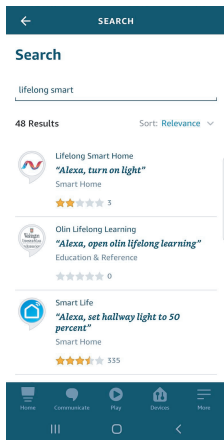






## BINDING AMAZON ALEXA

1. You can connect your device to Amazon Alexa easily by Amazon Alexa app.
  2. Navigate to the “Skills & Games” menu in Alexa app.
  3. Press search and enter “Lifelong Smart”. In the results click “Lifelong Smart Home”.
- This will take you to the Lifelong Smart Skills page.
4. Click “Enable to use”. You will then need to enter your Lifelong Smart account login details and press “Link Now”.
  5. In a few seconds your account will be linked to Alexa skills and a success notification is presented. Press “Close”.



## VOICE CONTROL WITH ALEXA

To control your device using Alexa, it is recommended to connect it to an Amazon Echo device. Echo needs to discover your device first. To discover, you can say “Alexa, discover device”. If the device has already been discovered during Alexa setup as described above, this step can be omitted.

To control your device with voice commands, you can use following commands (assuming you have named one switch as Bedroom Light) -

1. Alexa, turn on bedroom light.
2. Alexa, turn off bedroom light.
3. Alexa, switch on bedroom light after 2 hours.
4. Alexa, switch off bedroom light after 6 hours.

### 1. This warranty is void if:

- a. The completely filled warranty card is not presented at the time of servicing the product.
  - b. The product is not operated according to the instructions given under the user manual.
  - c. Damages are caused by lightning, abnormal voltage, water or other liquid intrusion, fire, flood, accident, negligence or improper handling.
  - d. Product has been damaged due to installation, repairs, alterations or modifications by unauthorized service organizations or persons.
  - e. Product label specifying the model number, serial number and production code has been removed and altered.
  - f. Defects or parts requiring replacement due to ordinary wear and tear, corrosion, rust or stains, scratches, dents on the casing or paintwork of the product.
  - g. Claims damaged and/or missing parts (accessories) after 7 days from the original date of goods received.
  - h. Defects or faults in product which have been used for commercial/industrial purposes or which have been rented/leased or have been otherwise subject to non-household/non-domestic use.
2. Repairs or replacements will be carried out by authorized service provider.
3. During the limited warranty period, Lifelong or its authorized service provider will repair without charge the defective unit inclusive of labor and parts and restore the unit to its optimum working condition. All defective parts used for the warranty repair should be surrendered to Lifelong and/or its authorised servicer.
