



## **BEFORE USING THE PRODUCT:**

- 1. Please check if this product is suitable for your location.
- 2. Please clean this product before using it for the first time.
- 3. Please charge until the light is turned off.
- 4. Do not throw away the product.

#### METHOD OF OPERATION:

- 1. The cleanser touches the skin through high-frequency vibrating silicone, which helps to remove oil stains and cosmetic residues in the pore, and also remove necrotic keratinocytes. It is recommended to clean all parts of the face for 15 seconds and enter the cleaning mode in first step.
- The first step is to remove makeup, moisten the face, apply cleanser and enter the cleansing mode.
- 3. In the second part, move the device from the chin, gently up to the ears along the jaw until the cheeks are completely clean.

#### **CHARGING METHOD:**

Insert the USB port of the charging line into the 5V charging head. Then insert the DC head into the circle on the right side of the cleaner. At this time, the red light flashes, indicating that the charge is in progress, the red light stops flashing, indicating that the power is full.
