

HOW TO USE

The Lifelong Detachable Body Massager can give you an effective full body massage in the comfort of your own home. The sturdy design and detachable feature ensure you can reach hard to reach areas of the body as well with ease.

- Step 1: Ensure that the device is switched off before you plug in.
- Step 2: Choose between 2 different massage head options Multiple point and rounded depending on your personal preference
- Step 3: Detach the massager with the two buttons on each side of the massager if you want to use it on easily accessible areas or use the full version for areas such as back etc.
- Step 4: Put your hand under the strap for a firm grip
- Step 5: Switch on the device by sliding the switch to ON position
- Step 6: The intensity and the speed of the massager can be adjusted with the button and the slider given on the upper left and right side of the device. You will also see LED changing intensity from high to low as you adjust the device according to your required comfort.
- Step 7: Guide the device to the area of the body to be massaged. You can stand, sit or lie down and use the massager

- 1. Split structure design, light and handy, great for a massage anytime, anywhere.
- 2. The main part of the massager can be used alone, relying on the locking strap fixed in the palm to make the massage simpler.
- Massager's handle is convertible. When attached one can reach hard to reach areas like back etc. and when detached it becomes much smaller for general use.
- 4. Continuously variable speed regulation can effectively stimulate the nerves and muscles for a refreshing massage.
- 5. Point massage helps relieve muscle pain.

Terms and Conditions
