Automatic heating

Please add warm or cold water below 30 degrees.

When the foot spa machine has been switched on, the heating will start automatically.

Temperature control

With the option of temperature control, you can select the heating temperature of your preference. The default temperature is 35 degrees. It increases by 1 degree. The maximum heating temperature is 48 degrees.

Adjustable time

Enjoy a relaxing massage in the comfort of your home for as long as you want. The appropriate time for a foot spa is generally 20 minutes.

Foot massage

The foot spa massager has automatic foot rollers. These rollers massage the feet thus giving a more relaxed foot spa experience

NOTE:

The appliance has a heating surface and must be used by people who are not sensitive to heat. If water overflows from the massager, it cannot be used.

METHOD OF USE:

- 1.Place the foot spa massager in front of a chair. Add water to the appropriate water level.
- 2. Press the power button to switch it on. Press the button again to turn of the massager.
- 3.After switching on the massager, put your feet into the foot spa and adjust the settings as per your preference.
- 4.Set the timer. The appropriate time for foot spa is generally 20-30 minutes which can be adjusted accordingly.
- 5.Before switching the massager off, turn off the heating button. Press the power button to switch of the massager.

MAINTENANCE AND PRECAUTIONS:

- 1. Add water first and then switch on the massager. It is strictly prohibited to use without water.
- 2. It is strictly prohibited to stand in the tub. It could lead to breakage of the tub's body.
- 3. When the massager is not in use, please empty the tub and place it in a shady area
- 4.Before leaving the factory, every machine will be opened and water released for inspection (This is done to test whether all functions are running normally). There could be some stains of
- water droplets which is normal. The products are unused.
- 5.Drink 1-2 cups of plain water before a pedicure in order to facilitate circulation and detoxification in the body. During the foot spa if you feel dizzy, pause for a while. When you feel better, you can
- start the foot spa. Sweating is a normal phenomenon but if you sweat excessively then stop.
- 6.During a foot spa, blood vessels of foot dilate and blood volume increases, resulting in decreased gastrointestinal and visceral blood. This affects the gastrointestinal digestive function. Avoid foot spas
- 30 minutes before and after meals

7.People who are insensitive to heat must be accompanied by someone. Patients with pacemakers and women during menstruation and pregnancy must follow the doctor's advice 8.After your foot pedicure/spa has been completed, drain the water inside the machine, wash again once with fresh water and let it dry in a cool place. If there is water stored in the machine for a long time, it may cause moisture damage to the internal parts.

9.If the product is to be cleaned, do not use alcohol, gasoline and other solvents. Wash with soap or detergent and rinse properly with fresh water,

10.If the power cord is damaged, please contact the customer care.

Terms and Conditions:

- 1. This warranty is void if:
- a. The completely filled warranty card is not presented at the time of servicing the product.
- b. The product is not operated according to the instructions given under the user manual.
- Damages are caused by lightning, abnormal voltage, water or other liquid intrusion, fire, flood, accident, negligence or improper handling.
- d. Product has been damaged due to installation, repairs, alterations or modifications by unauthorized service organizations or persons.
- e. Product label specifying the model number, serial number and production code has been removed and altered.
- f. Defects or parts requiring replacement due to ordinary wear and tear, corrosion, rust or stains, scratches, dents on the casing or paintwork of the product.
- g. Claims damaged and/or missing parts (accessories) after 7 days from the original date of goods received.
- h. Defects or faults in product which have been used for commercial/industrial purposes or which have been rented/leased or have been otherwise subject to non-household/non-domestic use.
- 2. Repairs or replacements will be carried out by authorized service provider.
- 3. During the limited warranty period, Lifelong or its authorized service provider will repair without charge the defective unit inclusive of labor and parts and restore the unit to its optimum working condition.
