## PRECAUTIONS BEFORE USE

- Keep the Lifelong Titanium Plus 750W Mixer Grinder With 4 Jars away from heat and sunlight.
- Clean the jars carefully before use.
- Do not place the machine on a wet surface.
- Never try to touch the moving parts or blades of the mixer grinder while in operation.
- Fix the jar to the base unit by turning it clockwise.
- Make sure it is firmly locked in position prior to usage.
- Never insert your hand or spatula or spoon, when in use.
- Never operate the mixer grinder without the jar lid.

- When removing the blade please keep the washer in a good condition for fitting again.
- The jars can be cleaned by using regular dishwashing soap.
- After thoroughly rinsing with soap, clean the jars with a dry cloth.
- Never store the jars with closed lids.
- Do not use any detergent soap solutions on the main body.
- Clean the body with a dry cloth before storing for next use.
- Never immerse the motor in the water for cleaning
- Since the blades are quite sharp, be careful while changing them
- Never pull the cord to take out the plug from the socket
- Always switch off the power supply button before cleaning, emptying or when not in use.
- For citrus fruits like oranges and sweet limes it is advisable not to use the plunger so that the seeds pop up automatically. However, for best results cut the fruit into small pieces and remove the seeds before extracting juice
- Do not use the Liquidizer jar for dry/wet grinding, grating, chopping or mincing functions
- Do not worry if you experience some burning smell when you run your mixer grinder for the first time.

This is due to the motor varnish getting heated for the first time. The problem should not recur in subsequent uses. If it does, please contact our customer care.













## **HOW TO USE**

#### FRUIT FILTER JUICER JAR

- Insert the fruit filter into the blender jar and rotate it slightly so that it settles down and the grooves get locked with the slugs on the blender jar wall.
- Place the lid on the jar and rotate it anti-clockwise to lock.
- Place the assembly onto the drive shaft of the juicer mixer grinder and rotate clockwise to lock it into position.
- Cut small pieces of fruits to be juiced.



- Remove the cap on the lid by rotating anticlockwise. Put the cut pieces into the filter and switch on the juicer mixer grinder.
- You can continue adding more fruit pieces from the centre opening in the lid as they are juiced.
- The juice is sieved out through the filter and the pulp/seeds get accumulated inside the filter and pour out the contents from the jar by tilting.

## LIQUIDIZING AND BLENDING

STEP 1: The Liquidizing and blending jar (refer fig 2) is used for preparation of shakes, juices etc.

STEP 2: Before starting the mixer grinder for the first time or after a long period of time, rotate the motor shaft with hand to ensure that it turns freely and smoothly.



STEP 4: Now switch on the grinder for operation

Note: Do not use this jar for wet grinding.

#### WET/DRY GRINDING

STEP 1: The wet /dry grinding jar (refer fig 3) is used for grinding items like Idli and dosa batter, coconut chutney, groundnut, red chili powder, sugar, palak etc.



STEP 3: Use small pieces of ingredients for grinding.

STEP 4: Fill the iar with ingredients up to the marked capacity.

STEP 5: Put the flat lid on top of the Jar. Grind at low speed for 15-30 seconds and then move to higher speed.

Note: Always move gradually from lower speeds to higher speed.

During grinding process, the jar might gethealed up due to friction.

Do not panic. This happens gradually.

#### **CHUTNEY MAKING**

STEP 1: The chutney jar (refer fig 4) is mainly used for making chutney.

STEP 2: Use small pieces of ingredients for grinding.

Step 3: Put the ingredients in the chutney jar for grinding. Hold the lid tightly so that it won't get healed up.

STEP 4: The ingredients should not be too large. Break ingredients into smaller pieces.

Note: The lid should be properly pressed.

## OVERLOAD PROTECTION

- The overload protector (OLP) is designed to protect the motor (refer fig 4) from burning.
- In case of an overload, the blade of the jar stops rotating and the motor gets jammed or starts heating up.
- If such a situation occurs the mixer grinder will automatically trip off and hence protect the motor.
- Let the motor cool down for a couple of minute. The red button of the overload protector switch located at the bottom of the mixer grinder has to be pressed for re-operation.
- If you have to reset the OLP again and again, try reducing the quantity of ingredients in the Jar.



## **CLEANING INSTRUCTIONS**

- Before use pour warm water in the jar, run for a few seconds and throw away the water.
- The cleaning of the mixer grinder and jars are very necessary for maintaining smooth operation of the mixer grinder and proper hygiene.
- After you have used the mixer grinder, use warm water to remove the smell of the material from the jars and then rinse under running water.
- In order to clean the blades thoroughly, remove the blades by using the spatula to loosen the screw by twisting the dome nut on the blade clockwise, while holding the coupler from under the iar.
