

ABOUT THE PRODUCT:



DESCRIPTION OF KEYS:



1. Power switch

Turns the power on or off.

Default massage run time is 15 minutes, over 15 minutes will automatically turn off the power.



2 Time setting key

Turn on the power, you can set the massage time, press the time by 5 minutes, the longest massage time can be set to 30 minutes, the shortest is 5 minutes.



3. Air pressure intensity adjustment key

Power on default is mid-range (L2). Total weak (L1) - Mid-range (L2) - Strong (L3) Three-speed adjustable. The intensity is displayed in the display window (L1, L2, L3).



MODE 4 6 mass

4 6 massage programs can be adjusted Built-in 6 automatic programs, respectively (P1, P2, P3, P4, P5, P6).

P1: For fitness massage function, (soles of the foot roller massage and air pressure massage at the same time work).

P2: For the health massage function; soles of the feet roller massage and air pressure massage at the same time work).

P3: For leisure massage function (foot roller massage and air pressure massage alternately work).

- P4: For the foot roller independent massage (pinch feet).
- P5: For the pressure massage (cover their feet).

P6: For the warm foot function (for heating the soles of the feet).

Mode is displayed in the display window (P1, P2, P3, P4, P5, P6).



5. Heating construction


Turn on or off the heating function of the soles of the feet, the display window shows (01) that heating is turned on, the display shows (00) meaning heating is off.



6. Pause key

Pause or turn on the running massage program.

FEATURES:



INSTRUCTIONS:

1. Connect the product and the adapter, and then connect the power plug to the outlet.

- 2. Sitting in the chair for their height, feet into the foot machine inside.
- 3. Select the desired massage program.
- 4. Unplug the power cord after use.

SAFETY PRECAUTIONS:

Read the safety information carefully before use and follow the instructions. NOTE

- 1. Recommended use time is 15 minutes, repeated use may lead to product overload.
- 2. Do not massage the wound or the injured body parts.
- 3. Users with sensitive skin should pay attention to not compress parts that may cause burns.
- 4. After each use, please turn off the power switch in a timely manner and remove the power

plug.

- 5. Do not use the product near electric heaters or other heat sources.
- 6. Do not use excessive pressure on the product, as it may cause failure.
- 7. Keep the product away from humidity or high temperature.
- 8. Do not touch the product with wet hands or connect the power supply with wet hands.
- Never pour water over the product, so as not to cause failure in case of dropping water, please immediately turn off the power switch and unplug the power plug from the outlet.
 Do not dismantle the product.
- 11. Do not stand on the product.
- 12. Prevent children or users who may not be able to take care of themselves without authorization to operate the product.
