





MARKING OF PRODUCT:

SAFETY PRECAUTIONS:

- 1. Use Liquefied Petroleum Gas at 2.942 KN/m² (30 gf./cm²)
- Ensure there are no inflammable substances kept near the Gas Stove
- 3. Use the Gas Stove for cooking purposes only
- For the hose / tube, use a quality rubber hose only, suitable for use with an LPG stove
- Do not use a plastic vinyl hose as it may be inflammable. The rubber hose should not touch any part of the Gas Stove or be kept underneath it
- 6. Switch off the fans in the kitchen when the Gas Stove is in use
- 7. Make sure the rooms / kitchen where the Gas Stove is placed in are well ventilated. It is not advisable to use the Gas Stove for long periods in a small room or in a closed place without proper ventilation
- 9. While in use & immediately after use, do not touch the pan supports as they get very hot
- For better & longer service, keep your Gas Stove clean at all times. The pan support & spill tray (according to model) can be removed for cleaning purposes
- Never attempt to dismantle or repair the Gas Stove on your own. In case of any difficulty or problem contact your gas dealer or contact our customer care executive to have it addressed

BASIC OPERATION:

- The LPG Stove is simple & safe to use. Begin by placing the Gas Stove on a horizontal working table
- Connect the Gas Stove to the gas cylinder by fitting the free end of the rubber tube to the inlet connection nozzle. The rubber tube should be laid in such a manner so as to avoid sharp bends
- 3. While lighting the burner, first open the gas-regulating valve on the cylinder. Bring a lighted match stick or gas lighter close to the burner which is to be lit. Then, push the relevant knob & turn it in the clock / anti clockwise (as per model specification) direction to the "ON" position
- 4. While putting off the burner, first close the regulating valve that is provided with the gas cylinder, & then turn the stove knob to "OFF" position
- 5. The gas cylinder should not be tilted horizontally while in use
- 6. Take care to avoid spillage while cooking as this may result in extinguishing of flame & clogging of burner holes
- 7. Before removing a dish from the burner, turn off the appropriate knob. As a safety precaution, keep the main regulating valve of the cylinder closed when you are not using your Gas Stove

GAS LEAK:

If gas leak is felt through a gas smell or otherwise, immediately close the main gas valve of the cylinder & any of the burners if they are already in "ON" position on the Gas Stove. Open up all windows & call your gas supply agent / gas dealer customer care immediately. Do not switch "ON" or "OFF" any electric point or light a match stick or use a lighter when a gas leak is detected / suspected

TROUBLESHOOT CHART:

| Problem | Possible Cause | Solution |
|------------------------------|---------------------------------------------|------------------------------------------------------------|
| Gas Stove does not ignite | Main gas valve closed | Open main gas valve |
| | Rubber hose bent / blocked | Straighten the hose, or remove the blockage or change hose |
| | No gas supply | Replace the gas source |
| | Air mixed in the tube | Repeat to ignite to remove the air in the hose |
| Gas leakage/ smell | Leakage from gas hose | Refit or replace the gas hose |
| | Gas knob not closed properly | Shut OFF gas knob properly |
| | Burner not lit after putting ON gas knob | Reignite the burner |
| | Leakage from gas cylinder regulator | Inform your gas dealer |
| If flame is abnormal | Flame ports are blocked | Clean the flame ports |
| | Burner top fitting | Fit burner in right position |
| | Knob position not correct | Knob should be at ON position |
| | Supply of Gas | Replace gas cylinder / regulator |

Terms and Conditions:

1.This warranty is void if:

- a. The completely filled warranty card is not presented at the time of servicing the product.
- b. The product is not operated according to the instructions given under the user manual.
- C. Damages are caused by lightning, abnormal voltage, water or other liquid intrusion, fire, flood, accident, negligence or improper handling.
- d. Product has been damaged due to installation, repairs, alterations or modifications by unauthorized service organizations or persons.
- e. Product label specifying the model number, serial number and production code has been removed and altered.
- f. Defects or parts requiring replacement due to ordinary wear and tear, corrosion, rust or stains, scratches, dents on the casing or paintwork of the product.
- g. Claims damaged and/or missing parts (accessories) after 7 days from the original date of goods received.

- Repairs or replacements will be carried out by authorized service provider.

All defective parts used for the warranty repair should be surrendered to Lifelong and/or its authorised servicer.
- All expenses incurred in collecting the unit (s) or part(s) thereof from authorised service provider as will as any other expenses and incidentals will be borne by the consumer.

Except as set forth above, there are no other express or implied warranty and all warrantied, conditions or other terms implied by statute or common law (including any warranty of satisfactory quality, merchantability or fitness for a particular purpose) are excluded to the fullest extent permitted by the lass.
