



ABOUT THE PRODUCT:

The Lifelong Gas Stove is an essential addition to your kitchen that gives you great value for money. Designed to make cooking convenient, efficient, and safe, this gas stove is engineered to avoid any gas leakage.

MARKING OF PRODUCT:



- A. Powdered Coated Pan Supports
- B. High Efficiency Burner
- C. Stainless Steel Body
- D. Stainless Steel Drip Tray
- E. Gas Knob

SAFETY PRECAUTIONS:

- 1. Use Liquefied Petroleum Gas at 2.942 KN/m² (30 gf./cm²)
- 2. Ensure there are no inflammable substances kept near the Gas Stove
- 3. Use the Gas Stove for cooking purposes only
- 4. For the hose / tube, use a quality rubber hose only, suitable for use with an LPG stove
- 5. Do not use a plastic vinyl hose as it may be inflammable. The rubber hose should not touch any part of the Gas Stove or be kept underneath it
- 6. Switch off the fans in the kitchen when the Gas Stove is in use
- 7. Make sure the rooms / kitchen where the Gas Stove is placed in are well ventilated. It is not advisable to use the Gas Stove for long periods in a small room or in a closed place without proper ventilation
- 9. While in use & immediately after use, do not touch the pan supports as they get very hot
- 10. For better & longer service, keep your Gas Stove clean at all times. The pan support & spill tray (according to model) can be removed for cleaning purposes
- 11. Never attempt to dismantle or repair the Gas Stove on your own. In case of any difficulty or problem contact your gas dealer or contact our customer care executive to have it addressed

OPERATING INSTRUCTIONS:

- 1. Begin by placing the gas stove on a horizontal working table.
- 2. Connect the gas stove to the gas cylinder by fitting the free end of the rubber tube to the inlet connection nozzle. The rubber tube should be laid in such a manner so as to avoid sharp bends.
- 3. While lightning the burner, first open the gas-regulating valve on the cylinder. The auto ignition burner is provided with Piezo-ignition system. Auto spark model is provided with multi-spark ignition system. For lighting the burner, press the multi-spark ignition system. For lighting the burner, press the operating knob fully and turn it to "ON" position. Simultaneously, press the Auto spark switch. The burner will light automatically.
- 4. While putting off the burner, first close the regulating valve that is provided with the gas cylinder, and then turn the stove knob to the "OFF" position. The gas cylinder should not be tilted horizontally while in use.
- 5. Take care to avoid spillage while cooking as this may result in extinguishing of flame and clogging of burner holes.
- 6. Before removing a dish from the burner, turn off the appropriate knob. As a safety precaution, keep the main regulating valve of the cylinder dosed when you are not using your gas stove

GAS LEAKAGE:

If gas leak is felt through a gas smell or otherwise, immediately close the main gas valve of the cylinder & any of the burners if they are already in "ON" position on the Gas Stove. Open up all windows & call your gas supply agent / gas dealer customer care immediately. Do not switch "ON" or "OFF" any electric point or light a match stick or use a lighter when a gas leak is detected / suspected

	Rubber hose bent / blocked	Straighten the hose, or remove the blockage or change hose
	No gas supply	Replace the gas source
	Air mixed in the tube	Repeat to ignite to remove the air in the hose
Gas leakage/ smell	Leakage from gas hose	Refit or replace the gas hose
	Gas knob not closed properly	Shut OFF gas knob properly
	Burner not lit after putting ON gas knob	Reignite the burner
	Leakage from gas cylinder regulator	Inform your gas dealer
If flame is abnormal	Flame ports are blocked	Clean the flame ports
	Burner top fitting	Fit burner in right position
	Knob position not correct	Knob should be at ON position
	Supply of Gas	Replace gas cylinder / regulator
