- 1. Open the cover of the main machine according to the indicated direction and put 3 AAA batteries inside. (Battery not included)
- 2. Close the battery cover
- Please confirm the anode and cathode of batteries.

HOW TO USE:

- 1. Place the 3 massage fingers of the device on the part you wish to massage, and press the top of the main machine with proper force for it to start working.
- 2. Detach the device from your body and release the button on the massager to stop the massage.

DEVICE CLEANING & MAINTENANCE:

- Moisten a soft cloth with medical alcohol or clean water to wipe the machine's body to remove the dirt.
- Please keep this machine in a safe place after use. No heavy weight is allowed on the machine.
- Please ask your professional technician for repair if any fault occurs.

DOS & DON'TS:

- Do not put any heavy weight on the massager.
- Clean the device with a slightly damp cloth.
- Do no wash any part of the massager.
- Do not disassemble the instrument by yourself.

- 1. This warranty is void if:

- e. Product label specifying the model number, serial number and production code has been removed and altered.

- g. Claims damaged and/or missing parts (accessories) after 7 days from the original date of goods received.
